Terms Of Business

Payment of Account

By signing the arrangement form, you are accepting our estimated list of charges. You agree that you are responsible for paying us the full price of the goods or services when such payment falls due and irrespective of the receipt of any sums due from any third party, including but not limited to any Government contribution.

For our Unattended Cremation Service

Full and final payment is required at least two (2) working days before the cremation takes place. If payment is not received by this time, the cremation may be delayed.

For Attended Cremation Service, Complete Service and Bespoke Service

We do not require any payment when you engage our services. Full and final payment is required within 21 days of the date of the Funeral. If full payment has not been received within 28 days of the service taking place, then we reserve the right to charge interest on the outstanding balance at a rate of 8.0% above the current Bank of England base rate.

Cancelling An Order For Our Services

For Attended Cremation Service, Complete Service and Bespoke Service

The client has the right to cancel this contract if they so wish within the cooling off period of seven (7) days from instruction.

For our Unattended Cremation Service

The client has the right to cancel this contract if they so wish within the cooling-off period of three (3) days from instruction.

For all services

You acknowledge that if the services are fully performed within the cancellation period, you will lose the right to change your mind and cancel the services. If you cancel after we have started the services, but before the services are completed, you must pay us for the services provided until you tell us that you have changed your mind.

To exercise your right to cancel, you must inform us of your decision to cancel by a clear statement in writing e.g. a letter sent by post or e-mail.
